What: A **challenging** day of races. Each participant runs a 5K, 400 meter, 100 meter, 1600 meter and 10K. All races are on the track. Points are awarded based on time. 1/4 inch or less spikes allowed.

Cost: \$35.00 for BRRC members. \$45.00 for non-members (postmarked by August 10). This includes a FINISHER'S singlet...THERE is a \$20 late fee after postmark date - You must preregister to get a singlet on race day. Singlet not guaranteed after postmark date.

NO SHIRT OPTION \$25 postmarked by Aug 23 (please don't mail after Aug. 23)- / \$40 Race day
***** NO shirt option is the only option day of race.

Awards: Plaques to the first male and female in the open (0-39), master's (40-54), and senior's (55+) divisions. Ribbons for places two through ten in each division.

Aid: Water will be provided in the 5K and 10K. Competitors will provide any other refreshments.
